Science4Peace Forum Civil Clause

- [°] Civil clause (German: Zivilklausel) is a voluntary commitment by academic institutions to engage exclusively in civil (i.e. non-military) research. (link)
 - The idea originates in Japan: In 1950, the Science Council of Japan established that its members will refuse to participate in military-related research projects. Such a declaration was repeated in 1967, and in 2017.
 - In Germany, Universität Bremen was the first to put a Civil Clause in effect. Its resolution no.5113 from 1986 declared:
 - Any participation of science and research with military use or purpose must be rejected by the academic senate. In particular the civil clause demands that members of the university reject research projects and funding which could serve weapon technology.

Science4Peace Forum Civil Clause

- Around 70 universities in Germany have already given themselves civil clauses, voluntary commitments to research, teach and study solely for peaceful goals and civil means and thus contribute to a truly civil world, including the MIN Faculty at the University of Hamburg.

"Research, teaching and studies at <u>Technische</u> Universität Darmstadt exclusively pursue peaceful goals and serve civilian purposes; research, particularly relating to the development and optimization of technical systems, as well as studies and teaching are focused on civilian use."

Science4Peace Forum Separation of civil and military research

- position paper of the German Ministry of Education and Research BMBF
 - •The possibilities for better integration of **military and civil research** are to be addressed
 - •Exchange and cooperation between **civil and military research institutions is to be intensified** in order to put knowledge relevant for research security and German research capabilities on a broader footing and to strengthen inter- and transdisciplinary cooperation.
 - •whether the various types of **civil clauses** are still appropriate in view of the changed geopolitical conditions and how civil clauses can be designed so that they take adequate account of the increasingly difficult differentiation of research in view of multiple possibilities for its use.

Science4Peace Forum Separation of civil and military research

- Referee Report 2024 of Expert Commission Research and Innovation:
 - remove strict divide between military and civil research
 - support of spillover and dual use
 - examples: DARPA (Defense Advanced Research Projects Agency) in US and military unit 8200 in Israel (participating in Gaza war)

Science4Peace Forum Civil Clause at CERN and DESY

- CERN statement of civil research in CERN constitution :
 - Article 2: "The Organization shall have no concern with work for military requirements and the results of its experimental and theoretical work shall be published or otherwise made generally available."
- DESY: Statement on research in "Guiding Principles statement"
 - •"Our research pursues goals that are peaceful and serve civil society"

Science4Peace Forum DESY research DESY research

- Staff meeting Jun 17, 2024:
 - Directory sees DESY's responsibility to contribute to the defense of our democratic system and starts an internal process with the aim of developing a common position of the laboratory.
 - In the three areas of "national resilience, national militarism (Wehrhaftigkeit) and national robustness" DESY can play a role, and possibly provide the use of DESY equipment for military research (PETRA IV).

Science4Peace Forum Questions - general Questions - general

- Didn't we always have an issue with Dual-Use?
- Opening explicitly for military research means a significant change!
- Does present political situation require a change of research policy and opening for military research?
 - why is a change needed?
 - who wants what and in which interest?
 - Pacifism: a Defense: see discussion in S4P Forum Jan 25, 2022
- Is military research (even for defense) to be performed at public international and national institutions?
- Peaceful role of science: science is building bridges Science For Peace idea
 - Science and peaceful research (not military research, but sometimes together with military) has led to Arms Control and Arms Control Treaties

Science4Peace Forum Questions - DESY Questions - DESY

- Discussion in public as well as among employees is necessary:
 - DESY ethics commission must be involved: not yet even informed!
 - Is really a change in DESY "Guiding Principles statement" "Our research pursues goals that are peaceful and serve civil society" necessary?
 - Dual use was always an issue, why explicitly allowing military research?
 - Similar procedures as at Universities with Civil Clause possible?
 - see Checklist for Civil Clause from TU Darmstadt to be send to ethics commission?
 - DESY directorate must explain political intentions:
 - is funding at risk, if not opened for military research?
 - is additional funding expected?
 - who makes pressure on DESY to change policy?
